NOTICE IS HEREBY GIVEN that the County of Santa Clara Board of Supervisors has scheduled a public hearing for Tuesday, **August 25, 2020, no earlier than 10:00 a.m.** to consider the following application:

Public hearing to consider text amendments to County of Santa Clara Ordinance Code Appendix I (Zoning) relating to Industrial Hemp regulations for unincorporated Santa Clara County. (File No. PLN20-052) (Supervisory District: Countywide)

The public hearing will be held either in the Chambers of the Board of Supervisors at the County Government Center, 70 W. Hedding Street, San José; or by virtual teleconference, pursuant to the provisions of Executive Order N-29-20, issued by the Governor of California on March 17, 2020, or the provisions of any applicable subsequent Executive Order.
