#### **School District Presentation**

Our Department recently held an informational training session with the maintenance staff from another Santa Clara County school district. They had some new questions and shared some information with us that we thought might be helpful for other districts.

#### **Pest Control**

Questions and Answers

- Q1: We have a bat problem in one of our buildings. What do you suggest we do?
- A1: The existence of a bat infestation poses a disease threat to your school as bats can carry rabies. It is also possible to get cystoplasmosis through contact with their guano. Vector Control suggests removing populations as soon as possible. A few pest control companies specialize in bat removal. We recommend you hire a company experienced with this kind of work. For more information you could call Vector Control at (408) 792-5010.
- Q2: What is a good product to control ants? (Our Department is merely passing along information we have been given and does not endorse one product over another.)
- A2: This school district has had good success with the material Maxforce®. This material is a brown colored bait that blends very well with dirt. Once applied, it is difficult to see. The key to the bait is to place it in the cracks and crevices along walkways or in the dirt away from buildings. (BE SURE TO READ THE LABEL FOR APPROPRIATE USE.)

## **Pesticide Safety**

Questions and Answers

- Q1: How often do I have to calibrate my spray equipment?
- A1: It depends on the materials you use, the type of nozzle you are using, and also the type of equipment. Make sure you read your equipment maintenance manual and test your equipment periodically. Using uncalibrated equipment can result in over-application or in uneven coverage.
- Q2: How often do I need to train my seasoned applicators?
- A1: Every pesticide handler must be trained <u>yearly</u> regardless of his or her experience. These training records must contain specific training topics and must be kept for the current year plus two years back. The only exception is for employees that have a license from the California Department of Pesticide Regulation. (A Qualified Applicator License or a Qualified Applicator Certificate) If an individual has one of these licenses they would be considered trained.
- Q3: Do custodians who <u>only</u> use disinfectants and sanitizers need to be trained annually?
- A3: Yes. The easy way to do this is to ensure that you are in compliance with your OSHA guidelines and are covering the pesticide safety training topics in your monthly safety meetings.

### **Pest Control Operators**

Tips for hiring a responsible pest control company

We have talked before about some of the factors your district should consider when choosing a pest control company. Other than assuring the company is familiar with the Healthy Schools Act, we have a few more suggestions for you.

#### Agricultural Pest Control Companies:

Apply pesticides outdoors to control weeds and insect pests like aphids.

When hiring a company we recommend that you ask to see the company's County registration. Every agricultural pest control company must register annually with our office. To be eligible for registration they must first have a person on staff that is properly licensed, and the company must have a valid Pest Control Business License from the Department of Pesticide Regulation (which requires them to be insured, etc). If you require a company to show you their registration form, you know that one, they are licensed, and two, they are under our regulatory oversight. An example of a registration card is shown below.

#### Structural Pest Control Companies:

Apply pesticides to control pests of buildings such as ants, cockroaches, spiders, mice, etc.

These companies are licensed through a different State agency. Their county registration process is a little different too. Structural companies must have a properly licensed person on staff to run the business, and they must have a valid Structural Business License from the Structural Pest Control Board. They do not receive a County registration card, but rather a receipt showing that they submitted an annual notice of intent to perform structural pest control within the County. If you hire a structural company, they should be able to provide you a copy of the County's receipt. Another option would be to call our office and ask if they have renewed for the current year.
